



LEGAL TERMS AND CONDITIONS FOR PARTICIPATION IN THE XIII PHOTOGRAPHY CONTEST “FotoAPICULTURAcaliere”

Laboratorios Calier, S.A., with registered address at C/ Barcelonès 26, 08520 Les Franqueses del Vallès, Barcelona, Spain, and Tax ID No. A-08291924 (hereinafter, “**Calier**”), has organized the **XIII Photography Contest “FotoAPICULTURAcaliere”**, which will be governed in accordance with the following Terms and Conditions:

Participants

Any natural or legal person **residing in Spain, France, Italy, or Portugal** may participate in this contest. Employees of Calier or other companies belonging to Grupo Indukern, S.L., as well as their direct relatives, are not eligible to participate.

Submission

Each participant may submit a **maximum of 3 photographs**, but may win only one prize. Submissions must be sent via email to: **fotoapicultura@calier.es**.

Photographs must have a minimum resolution/size of 200 dpi / 1500 x 2300 pixels. Any photograph not meeting these requirements may be automatically disqualified.

Photographs deemed by the jury to violate the dignity of people or animals, or those containing watermarks, text, or identifying data, will not be accepted.

Each photograph must include:

- Author’s name
- Contact email
- Contact phone number
- Title of the photograph
- Location where the photograph was taken

Theme

The contest includes 3 categories:

- **General Category:** Beekeeping theme, especially photographs of *Apis mellifera iberica*.
- **Beekeeping Category:** Beekeepers, beekeeping, and its environment.

- **Special Category:** Bee health, management, and pollinating insects.

All photographs must be original and unpublished.

Territorial Scope

The contest will take place in Spain. Participation is open to individuals or legal entities residing in Spain, France, Italy, or Portugal who are over 18 years of age.

Timeline and Submission Deadline

The submission period **will open on May 1 and close on September 30, 2026.**

The jury's decision will be announced on December 1, 2026, on the website www.fotoapiculturacalier.es, and winners will also be notified directly.

The jury's decision is final.

Prizes

Three winners (one per category) will be selected.

Additionally, 13 extra photographs will be selected for the "FotoAPICULTURAcasier" 2027 Calendar.

Prize options:

1. **Mini projector with WiFi and Bluetooth** (or similar) + **diploma**
2. **Acer Swift 3 laptop** (or similar) + **diploma**
3. **Apple iPad (10.2", 64 GB)** (or similar) + **diploma**

*You cannot be eligible for the prize in two consecutive years.

Image Rights

Participants certify:

- That the photographs submitted to the competition do not infringe the image rights of third parties, or that they have obtained the necessary authorisation from them for any reproduction or exhibition.
- That they hold the relevant authorisations from the people appearing in the photographs, as well as from the owners of any animals appearing in them.

Participants shall be liable for any claims by third parties arising from image rights and intellectual property.

Usage Rights

The copyright of the winning images belongs to the authors. All participants agree to transfer the exploitation rights of the photographs submitted to the competition for use in the 2027 “FotoAPICULTURAcálier” Calendar, the Calier website or publications, including for promotional purposes, without requesting any compensation in return for their use.

Taxation

Some of the prizes in this promotion may constitute capital gains; therefore, the value of these gifts will be subject to the applicable personal income tax regulations at the time they are received.

Acceptance and retention of the Terms and Conditions:

Participation in this competition implies, in itself, acceptance of the terms and conditions and the jury’s decision in all matters arising from the competition and the selection of the winners. If you do not agree, you must not take part in this competition.

The terms and conditions are published on the website www.fotoapiculturacalier.es.

Calier reserves the right to cancel, extend, shorten or modify the competition at any time should circumstances so require, without the need to justify its decision and without any liability arising therefrom, provided that this does not prejudice the rights already acquired by participants. In such cases, Calier shall inform participants, as well as any other potential entrants, through the means it deems appropriate.

Any claim relating to the promotion, the awarding of prizes, etc., must be submitted within a period of sixty (60) calendar days from the final day of the competition.

Limitation of Liability:

By way of illustration but not limitation, Calier shall not be held liable for any loss, theft, delay or any other circumstance attributable to third parties that may affect the running of this competition, nor for the use made by participants of any prize obtained in this competition. Calier shall not accept any liability for any loss or damage of any kind suffered by participants, winners or third parties.

Calier shall not be held liable in cases of force majeure or unforeseen circumstances that may prevent the competition from taking place or the full or partial enjoyment of the prize. In the event that this competition cannot be carried out due to detected fraud, technical errors or any other reason beyond Calier's control that affects the normal running of the competition, Calier reserves the right to cancel, modify or suspend it, including the participation website.

Personal Data Protection:

Participants' data shall be processed in accordance with the provisions of the General Data Protection Regulation (EU) of 27 April and other applicable legislation (including the Organic Law on Data Protection, among others).

Such data shall be incorporated into a file for which Laboratorios Calier, S.A. is the data controller and owner, and may be processed solely for the purpose of managing participation in the competition, awarding the prizes, and/or for advertising or commercial prospecting purposes by any means, including email, in accordance with the preferences indicated upon registration for this competition.

Under no circumstances shall data other than those indicated be processed. This processing is based on the contractual performance inherent in participation and acceptance of these terms and conditions, since once participation is freely and voluntarily accepted, it is necessary to accept these terms and the processing of personal data essential for the proper execution of the competition.

Participants authorise Calier to reproduce and use their name in any promotional or advertising activity related to the competition in which they have been declared winners, without such use entitling them to any remuneration or benefit other than the awarding of the prize obtained.

The data shall not be disclosed or transferred to third parties, except for their publication in the relevant medium and to those collaborators necessary for the delivery of the prize, as well as to those entities required for compliance with legal obligations (including Public Authorities, among others).

The processing of data shall be carried out in strict confidence and with the application of security measures ensuring its confidentiality, integrity and availability. The data shall be retained for the duration of the competition and, in the case of winners, until they exercise their right to erasure. Once the competition has ended, the data shall be retained only for the period necessary to comply with legal, tax and administrative obligations to which the participants and Calier are subject.

These terms and conditions shall be governed by Spanish law. Any claims or disputes arising in connection with the validity, interpretation or performance of these terms shall be subject to the jurisdiction of the Courts and Tribunals of the city of Barcelona.
